THE BOARD OF ASSESSMENT REVIEW WILL MEET ON TUESDAY MAY 24 BETWEEN THE HOURS OF 10 AM AND 12 PM AND BETWEEN THE HOURS OF 6 PM AND 8 PM AT THE ERWIN TOWN HALL, 310 TOWN CENTER ROAD, PAINTED POST, TO HEAR AND EXAMINE ALL SCHEDULED/ FILED COMPLAINTS IN RELATION TO ASSESSMENT UPON THE APPLICATION OF ANY PERSON BELIEVING HIMSELF TO BE AGGRIEVED. THOSE WISHING TO HAVE THEIR COMPLAINT REVIEWED BY MAIL MAY SUBMIT A FORM RP-524 AND SUPPORTING DOCUMENTATION ON OR BEFORE MAY 24TH. COMPLAINT FORMS AND ACCOMPANYING INFORMATION MAY BE SUBMITTED BY MAIL, EMAIL, OR VIA THE DROP BOX NEAR THE MAIN ENTRANCE TO THE ERWIN TOWN HALL

WE ARE REQUESTING THAT COMPLAINT FORM RP-524 AND SUPPORTING DOCUMENTS FOR SCHEDULED APPOINTMENTS BE FILED WITH THE ASSESSOR BY MAY 20TH. ATTENDANCE WITH YOUR COMPLAINT IS NOT NECESSARY FOR IT TO BE HEARD; HOWEVER THE COMPLETED COMPLAINT FORM MUST BE TIMELY FILED.
