#### Enhanced STAR Exemption:

For those turning 65 in 2025 with a 2023 gross income under \$107,300.

#### STAR Credit for New Homeowners:

Apply through NYS Department of Taxation and Finance, call (518) 457-2036 or visit [www.tax.ny.gov](http://www.tax.ny.gov).

#### Limited Income Senior Citizen Exemption:

Available for residents 65+ with a 2023 income below \$43,400.

# HIGHWAY DEPARTMENT WINTER TIPS

As winter approaches, we want to remind everyone of the necessary rules and regulations that provide for your safety and the traveling public's safety on main roads and neighborhood streets within the town during the winter season.



- When clearing your driveway of snow, the snow must be kept on your own property.
- No parking on highways, shoulders, or within 3 feet of pavement from 2 AM to 7 AM for snow removal and safety.
- During snow or ice events, every effort will be made to keep roads open. Please be patient.
- Be considerate of the snowplow operators.
